## ARBITRATOR AND MEDIATOR

**Pete Michaelson** arbitrates and mediates complex, often high-stakes/high-risk, international and domestic disputes, principally: IP (particularly patent), IT, telecom, general technology and energy.

Pete is an approved arbitrator and mediator for the USDC-EDNY and an approved mediator for the N.J. Superior Court, and a panelist for various widely respected domestic and international ADR organizations, including:

- ICC
- London Court of Int. Arbitration
- AAA and ICDR
- Chartered Institute of Arbitrators
- Financial Industry Regulatory Authority (FINRA)

Pete is also a Fellow and Chartered Arbitrator of the Chartered Institute of Arbitrators (UK), Fellow of the College of Commercial Arbitrators (US) and of the ACICA (Australia), and an accredited mediator for CEDR (UK).

### Substantial matters recently handled:

- **Arbitrated**, as sole arbitrator, a contract dispute concerning a web-based energy management system with damages claimed of US \$ 90-110 Million.
- **Arbitrated** as sole arbitrator, a multi-million dollar US patent dispute, concerning digital signal processor architecture, sent to arbitration after conclusion of trial discovery. Arbitration, including evidentiary hearing and rendition of reasoned award, occurred on an expedited basis, under the AAA rules, in approximately 7 weeks.
- **Arbitrated**, as panel chair, a US patent dispute, involving a antibody-based pharmaceutical drug with damages claimed of approximately \$ 100 Million, sent to arbitration after conclusion of trial discovery. Arbitration, including a two-week evidentiary hearing, occurred on an expedited basis, under the CPR rules, over approximately 3 months.
- **Arbitrated**, as a member of a three-person panel, an international telecommunications bilateral investment treaty (BIT) dispute involving a foreign government as respondent with damages claimed of approximately \$ 150 Million.
- **Arbitrated**, as a member of a three-person panel, a US patent dispute involving coronary stents with potential liability estimated between \$ 400-800 Million.
- **Mediated** an international patent dispute involving both mechanical and electronic aeronautical technologies with potential liability to each side of approximately \$ 300 Million.
